# **Conservation Reserve Program – Transition Incentives Program**

#### What is it?

CRP-TIP was created in the 2008 Farm Bill to help beginning, socially disadvantaged, or veteran farmers access valuable farmland while conserving natural resources. Retiring farmers or landowners who are enrolled in CRP with a contract set to expire are eligible for two extra years of CRP rental payments if they rent or sell their land to a beginning, socially disadvantaged, or veteran farmer – with certain conditions.

# How does a land owner with an expiring CRP contract qualify?

- The land owner must have a CRP contract that is set to expire.
- The land owner must sell or lease the expiring CRP land to a beginning, veteran, or socially disadvantaged farmer or rancher who is not related to the land owner.
  - If the land is leased, the lease must be an irrevocable lease of at least five (5) years.
  - The beginning, veteran, or socially disadvantaged farmer must return some or all of the land to production using sustainable grazing or crop production methods.
  - The beginning, veteran, or socially disadvantaged farmer must be allowed to develop a conservation plan and begin the organic certification process or install conservation practices and initiate land improvements during the last year of the contract.
- As a practical matter, this means an agreement must be in place well before the CRP contract expires.

# What must a beginning, veteran, or socially disadvantaged farmer or rancher do to qualify?

- Develop a conservation plan for the land.
- Begin conservation practices, land improvements, or organic transition within the last year of the expiring CRP contract.
- The beginning, veteran, or socially disadvantaged farmer is eligible immediately to enroll partial field conservation practices in CRP following the expiration of the land owner's CRP contract, provided that the beginning, veteran, or socially disadvantaged farmer has control of the property and meets all other qualifying conditions of CRP.



# The legalese

- The ability to qualify for extra CRP payments is subject to funding availability.
- The land owner with the expiring CRP contract and the beginning, veteran, or socially disadvantaged farmer must agree to be jointly and severally responsible for complying with both the provisions of the Transition Incentives Program agreement, and must also agree to be jointly and severally responsible for any payment adjustments that may result from violations of the terms or conditions of the Transition Incentives Program.

# How do I get started?
